**MEMORANDUM OF UNDERSTANDING**

**Between  
Vezobala High School, Duku  
And  
TeamTeach**

1. Purpose

With the object of promoting their co-operation in community service, Vezobala High School and TeamTeach, individually also "Party" and collectively the "Parties", enter into the following Memorandum of Understanding ("MoU").  
In this arrangement, Vezobala High School (located at Dukuduku South Mtubatuba 3935) agrees to give permission to TeamTeach (Located in Bangalore, India) to conduct community service in their school which will benefit the society and the local community.

2. Forms of Co-operation

Within such terms as are mutually acceptable for the Parties, the following forms of co-operation, amongst others, may be pursued hereunder:

- Provision of support from Vezobala High School towards the cause of community service.
- Provision of permission from Vezobala High School towards the cause of community service to conduct teaching activities in their school.
- TeamTeach will try its best to engage with the students by sending them curriculums (a few ppts), having online session (if accessible), connect with students to help them or clear their doubts in any of the subjects taught by TeamTeach, etc.

3. Party Relationship

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. The number of hours clocked in community service will be under Vezobala High School and TeamTeach. Under this agreement, Vezobala High School also promises to conduct similar activities of teaching (if possible and accessible) and declare publicly the relation with TeamTeach. Under this agreement, Vezobala High School also promises TeamTeach to help it grow by referring it to other similar schools (as seen fit by them).
